I am voluntarily participating in this tournament. ## TOURNAMENT RULES & REGULATIONS

*Dates: April 28<sup>th</sup>-30<sup>th</sup> (Rain Dates: May 12<sup>th</sup>-14<sup>th</sup>)*

- 1. Safety First:** This is a recreational event. Do not push your training limits or violate safe practice. The TBSC & the FSDA recommend that no competitors exceed the recreational diving limit of 130 feet of salt water.
- 2. Tournament Kickoff Party:** The Kickoff Party will be held Wednesday, April 12<sup>th</sup>, from 7:30pm until 10pm at [Ferg's Sports Bar & Grill](#) (St. Petersburg, FL). This is an open event hosted by the TBSC to welcome all participants and the community as a whole to some fun and festivities prior to the competition. The Kickoff Party is also an opportunity for participants to complete an Early Tournament Registration.
- 3. Early Registration:** Early Registration may be completed online at [TournamentHub](#), in person at [Aquatic Obsessions Scuba](#) (St. Petersburg, FL), or during the Tournament Kickoff Party. All registration forms must be completed with accompanying Tournament Waiver & Registration and tournament fees, and be postmarked or hand-delivered to the TBSC via one of the aforementioned options by *Wednesday, April 12<sup>th</sup> at 11:59pm to be eligible.*
- 4. Early Registration Bonus:** A FREE Tournament Collector's T-Shirt and special discounted tournament entry rate are offered to any participant who registers early (reference Registration Form for details).
- 5. Early Registration Confirmation:** To confirm that a participant's mailed Early Registration form was properly received, each Early Registered participant may call *(727) 344-3483 from April 13<sup>th</sup> through April 27<sup>th</sup>.* This confirmation will allow every participant with Early Registration to rest assured that his/her paperwork has been received and is in proper order.
- 6. Captain's Meeting (Final) Registration:** Starts at 7:00pm on April 28<sup>th</sup> and concludes at 8:00pm. This will be the final chance to register for the tournament. If turning in a Registration Form for someone on your boat, please ensure every part of the Tournament Waiver & Registration Form is accurately completed (*No Exceptions!*)! The Captain's Meeting and Final Registration will be held at [Aquatic Obsessions Scuba](#) (St. Petersburg, FL).
- 7. Mandatory Diver's Check-In:** At least one Representative Diver from each boat must be present at the Diver's Check-In Meeting held during the Captain's Meeting to represent himself and those on his/her boat. This allows the Representative Diver for his/her team to acquire verify tournament entry paperwork, acquire mystery tickets and shooter's bags, witness the official tournament time, and be privy to any last minute rule changes. To ensure a smooth acquisition of your teammate's paperwork at the Diver's Check-In make sure your teammate has confirmed receipt of his/her registration (Rule #5).
- 8. Captain's Meeting:** Starts at approximately 8:05pm. The Final Registration, Diver's Check-In Meeting, and the Captain's Meeting will be held in succession from 7:00pm to 8:30pm on Friday, April 28<sup>th</sup>. This will take place at [Aquatic Obsessions Scuba](#) (St. Petersburg, FL). The TBSC will host satellite Captain's Meetings in other locations throughout Florida. For additional information on satellite locations contact the TBSC at (727) 344-3483.

- 9. Official Entry & Eligibility:** No diver is officially entered in the tournament until the TBSC has received a properly filled out Waiver and Registration, and all fees are have paid. Waiver & Registration are completed by using this form and submitting to the TBSC by mail or in person, or online at [TournamentHub](#). All participants, except Juniors, must be current FSDA members. The \$20.00 FSDA dues for 2017 may be paid with a participant's registration. Junior Division (ages 12-17) are guests of FSDA and exempt from FSDA membership requirement. Additionally, all participants must possess a valid Florida Saltwater Fishing License.
- 10. Rule Changes:** The TBSC reserves the right to make any last minute rule changes at the Captain's Meeting. This is one reason why at least one Representative Diver is required to attend the mandatory Captain's Meeting.
- 11. Tournament Spearfishing Day:** The Spearfishing Day is Saturday, April 29<sup>th</sup>, with the tournament officially beginning at sunrise and concluding at sunset. The Rain Date for the tournament is Saturday, May 13<sup>th</sup>, sunrise to sunset. *There will only be one Rain Date for this tournament.* If the original date is moved to the Rain Date and the Rain Date is deemed unsafe to dive, the TBSC will still host the prize selection, raffles, and festivities on Sunday, May 14<sup>th</sup>.
- 12. Scoring/Points:** The tournament participant must choose which fish to weigh-in prior to arriving at the Weigh-In stage. Tournament officials will not weigh fish individually, to determine for the participant, which fish is the largest. Each participant will receive one (1) point per pound and five (5) points per fish weighed. There is a point limit per fish of twenty (20) points for weight and the five (5) points awarded for the fish, with a maximum total point limit per fish of twenty-five (25) points. Lionfish receive only five (5) *bonus* points per fish weighed with a maximum of ten (10) total bonus points for Lionfish. Tied scores will be broken by dividing the participant's total fish weight by the number of fish with the winning honors going to the higher score. Any further requirements for the resolution of tied scores will be at the sole discretion of the TBSC Officers.
- 13. Weigh-In:** The Weigh-In will take place on Sunday, April 30<sup>th</sup>, at [Ferg's Sports Bar & Grill](#) (St. Petersburg, FL). All participants' fish must be in the Weigh-In line *no later than 12:00pm (Noon), No Exceptions.* The Weigh-In will open at approximately 10:30am.
- 14. Awards:** Trophies and prizes will be awarded on Sunday, April 30<sup>th</sup>, after the Weigh-In, and once the scoring calculations are completed. The 1<sup>st</sup> Place Shooter (participant with the highest aggregate score) will get the 1<sup>st</sup> Place Trophy and the next subsequent four top-finishers will receive trophies for 2<sup>nd</sup> through 5<sup>th</sup> place. Trophies will also be awarded for the top aggregate scoring *Junior, Female, Freediver, and Mixed Pair, along with the Largest Fish per Category, and Most Lionfish.* If two participants are tied for Largest Fish per Category or Most Lionfish, the tiebreaker will go to the participant with the highest aggregate tournament score. Any further requirements for the resolution of tied scores will be at the sole discretion of the TBSC Officers.

- 15. Prizes & Mystery Tickets:** Each participant will receive ONE (1) Mystery Ticket along with his/her Shooter's Bag at the Captain's Meeting. This ticket will provide each competitor a chance to win one of the prizes donated by the Tournament Sponsors. These prizes are a bonus for the participants and the amount and type of prizes are dictated by the generosity of our Sponsors, and are randomly picked via a drawing. *New for 2017, the Top Five Aggregate Shooters will have first picks in tournament ranking order from the prize table in lieu of a Mystery Ticket.* The remainder of the tournament participants will pick prizes in random order via the drawing of Mystery Tickets. Every participant will have an opportunity to pick a prize. All the prizes will be worth a retail value of at least \$60. Participants must be present to accept a prize.
- 16. Junior Division:** This division is comprised of participants aged 12 (minimum tournament age) to 17 years old. Junior competitors must be certified divers and have a signed release from their parent or guardian. As with the adult participants, Junior participants should not exceed any depth or dive in any conditions that they are not officially trained or certified to handle. Furthermore, all Junior participants should be properly supervised by an Adult. A trophy will be awarded to the Junior participant with the highest combined aggregate score, however, all Juniors participants compete for all other awards and prizes with the adult competitors.
- 17. Mixed Pair Division:** This division is comprised of a two participant team who are diving from the same boat or the same shore dive area. Two types of dive teams may constitute a Mixed Pair, either an adult male and adult female or an adult of any gender and a minor of any gender. Trophies will be awarded to Mixed Pair tem with the highest combined aggregate score.

\*Despite only two lionfish counting towards tournament points, all participants are encouraged to harvest as many lionfish as possible. The TBSC sponsors various marine conservation organizations and charities whose representatives will be present to take scientific samples and/or accept all lionfish as charitable donations. Additionally, a lionfish trophy will be awarded to the participant who harvests the most lionfish.

- 19. Fish Eligibility:** All participants must follow and abide by all local, State, and Federal laws. All fish must be legally taken and landed by the participant who is awarded the points. The use of Powerheads is prohibited. All fish must be physically present in the Weigh-In line by 12:00pm (Noon) on Sunday, April 30<sup>th</sup>, for tournament eligibility. Each participant's fish must be presorted, fully and properly gutted, on individual stringers, and well iced. All fish turned in must be in a clean and whole condition (*minus the removal of guts*) and have all appearances of freshness. Fish that are shorter than State/Federal size regulations or that do not appear to be well iced and look fresh as per the judgment of the tournament Weigh Master, cannot be weighed, or if already weighed, can be disqualified. Only one participant of a tournament boat is required to weigh-in the fish for any fellow members of his boat. If a participant is weighing-in fish for a teammate, he/she must know the teammate's full name.
- 20. Fish Donation:** The TBSC will be collecting donated fish for local charities and community support programs. To incentivize donations, two (2) Fish Tickets will be given for each donated Grouper, Hogfish, and Snapper, and one (1) Fish Ticket will be given for each donated fish from all other categories/species minus lionfish. During the Awards Ceremony, the TBSC will conduct a raffle using the Fish Tickets and award a specialty prize to the participant with the winning ticket. This prize will be exhibited at the Captain's Meeting and the Weigh-In.
- 21. Disqualification:** Any cases of cheating or unsportsmanlike/unethical behavior will result in a disqualification from this tournament and possibly all future tournaments. A failure by the participant to have his/her fish present in the Weigh-In line by 12:00pm (noon) or presenting a fish for weigh-in that is less than the minimum eligible size is cause for automatic disqualification of that participant from the current year's tournament. All official times and requirements shall be reiterated at the Captain's Meeting and managed by the TBSC President.
- 21. Protest:** Any participant may file a protest with the TBSC Offices prior to the start of Award Ceremony. All protests will be resolved by the Tournament Committee consisting of the current TBSC officers; President, Vice President, Secretary, Treasurer, Director of Development. All decisions from the Tournament Committee shall be made in a timely manner and will be final in judgment.
